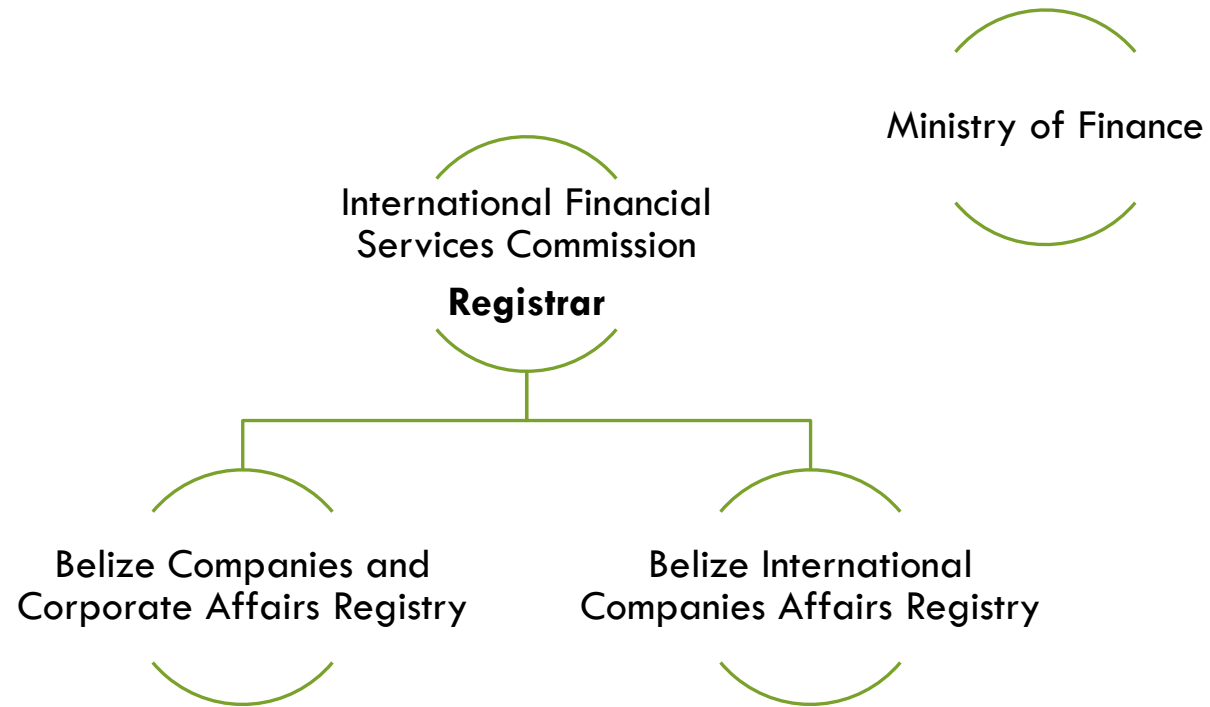

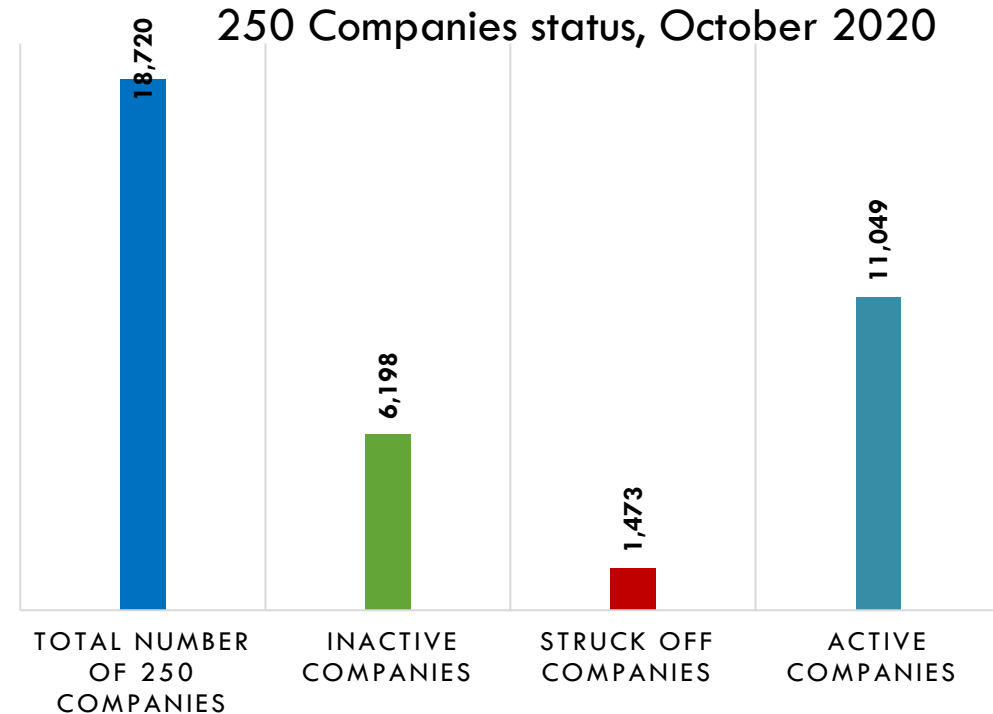
2. INCORPORATE A

3. SUBMIT ANNUAL RETURN

APPLICANTS AND BUSINESS OWNERS RESPONSIBILITY

- ✓ Have forms properly filled out and supporting documents in order.
- ✓ Submit Annual Returns on time to remain in good standing and active.



- **Struck off companies-** removing a company from the register and dissolving it. The company ceases to exist.
- **Inactive companies-** Companies that have not filed an annual return or any other activity after 2016.
- **Active companies-** companies that are in good standing and have filed annual returns up to the present year.
