

The Fiscal Incentive Program aims to encourage genuine investments in Belize for both existing and prospective investors through the granting of **Custom Duty Exemptions**.

Qualification Criteria:

The Company must be registered in Belize.

Business Activities must provide benefits to the economy of Belize.



Two types of programs promoted under the FI regime

Small Medium Enterprise Program

- ➤ The business can be a natural/legal person or an unincorporated entity.
- ➤ The business must have at least 51% Belizean ownership;

Regular Program


- Must be an incorporated entity under the Laws of Belize.
- No restriction on business ownership.
- > Investment must be more than BZ\$300,000.

STEP 04 Cabinet Decision

Subject to receiving approval, BELTRAIDE executes the publication period and statutory instruments documents.



The DPA Program is intended to support investments that engage in International Trade, Value Addition inclusive of technology transfer, generation of employment and production according to standards of the intended market.

Special Designated Processing Area (DPA)



Designated Processing Area Developer

A company established to administer a DPA. Developers provide factory space, communications, water/sewage networks, power, and any other facilities to companies in the zone.

Designated Processing Area Business

A private party that has been granted a Certificate of Compliance and conducts a trade or business including but not limited to manufacturing, commercial, office, warehousing, professional or other value added activities.

Special Designated Processing Area

Companies on which DPA status is conferred wherever they locate to accommodate resource-base activities. This is a highly flexible incentive enabling companies to operate from convenient locations while enjoying DPA benefits.
